IX. LIBRARY DIRECTOR'S REPORT

The village asked for an elevation confirmation survey, which Newman Architects arranged. We are still waiting for their final report, so the building permit can be issued. Brown suggested Suddarth seek an adjustment in fees, due to the delay.

A temporary brick wall portion has been built on the north side of the building, to test match of the colors of brick. Another will be built to try to find a closer match.

The move is scheduled for July 12, and asbestos abatement July 15-18.

No legislative news at this time. The concealed carry bill has passed, but not been signed yet.

The new internet connection is running, and is faster than the previous one. Suddarth will arrange for patching of the parking lot where the asphalt was cut to bring the line in.

There was a hygiene issue with the men's bathroom on a Tuesday evening, a PADS night. Staff have consulted with PADS, and are working to get better oversight of the PADS guests on Tuesday evenings.

The village board passed the Building and Maintenance levy, with two "no" votes. Notice was published in the Daily Herald and will be filed with the county.

Suddarth reported on various sessions he attended at the ALA conference.

The receipt printer problem is fixed.

Bushes on the east side of the driveway will be trimmed.
